NASSCO BREMERTON Additional Subcontractor Requirements

All temporary ventilation ducting shall be constructed of metallic or spiral reinforced material and meet the requirements of UL-94, flammability classification: VO. Temporary ventilation units used on hangar bay level must operate at noise level of no greater than 68db or be enclosed in noise reduction housings that bring the decibel levels to 68db or lower.

Sub-Contractor tool air hoses shall be equipped at one end with 1/2 inch Hansen male quick disconnect fittings to connect to Government air system manifolds.

Sub-Contractor vehicles granted access to pier/security areas are to drop off or pick up equipment only. Vehicles entering pier sentry checkpoints shall disembark all passengers so that passengers and their associated tool bags are passed through check point screening equipment.

Prior to introduction or use of Sub-contractor-owned/leased land mobile radio, citizen's band or General Mobile Radio Service (GMRS) equipment on PSNS property written permission must be obtained via NASSCO-Bremerton Security Office.

Vacuum cleaners used shipboard shall be metal canisters and tops and empty daily at the end of each shift in the appropriate waste receptacle, based upon the contents of the canister. Mark each metal canister vacuum cleaner exterior with Company name and Shop/Code responsible. Wait until 30 minute has elapsed, after hot work is secured, prior to using vacuum cleaners to clean-up debris at a hot work site. Plastic Canister vacuum cleaners may still be employed for general housekeeping in shop, dry-docks and work areas off-hull

Captain's passageway is to be kept free of temporary services installation and foot traffic unless specifically authorized by the Assigned Project Manager.

Prohibit Subcontractor employees from eating food or drinking beverages aboard ship or in the shipyard except at Government designated areas. No coveralls or soiled work clothes are permitted in designated eating areas.

Ensure all Subcontractor employees wear appropriate safety equipment and hard hats with the company's name and the employee's name clearly visible. Wear Government provided identification badges visibly at all times.

Notify Subcontractor employees that personal property, such as tool boxes, special tools, clothing and so forth taken aboard ship is subject to search and inventory daily on arrival and departure. Prohibit employees from leaving personal property onboard ship unattended. Subcontractor employees may be subject to additional screening when boarding the vessel by being required to pass through metal detection devices and additional security checks at point of entry to the ship.

Ensure all Subcontractor employees that will access the ship have attended training associated with the material with in the following documents and that certification of training accomplishment has been provided to the assigned Project Manager;

- DOD Instruction 5200.8, Security of DOD Installations and Resources

- SER 106/077, Safety and Health Requirements for Contractors Performing Work at the Bremerton Naval Complex Dated May 10 Dated 2013

The submission of Training Certification must be submitted prior to accessing the Ship. If the Subcontractor does not have either of these documents the assigned Project Manager can provide. Before new employees arrive on the ship an update of the Training Certification submission is required.

Provide training to all subcontractor employees, prior to assignment of shipboard work, in the requirements of confined and enclosed spaces and other dangerous atmospheres and the following specific topic areas:

- Precautions prior to entering compartments, tanks, voids or other areas of the ship
- Work authorization and tag-out of systems and equipment
- Hot and cold work interface
- Emergency response for injuries, fire, flooding or other incidents onboard the ship
- Working from scaffolding or ladders
- Housekeeping requirements
- Working aloft or working over water
- Personal fall protection and lifesaving equipment
- Safeguards in working with toxic or hazardous substances

Record of training completion shall be available upon request.
